Due to the manufacturing process and individual testing of raw materials used for production, the manufacturer of the product line I AM INK does not expect any:

oCarcinogenic , mutagenic or toxic for reproduction substances according to Annex VI Part 3 of the CLP Regulation (except substances with an effect by inhalation). These are below the detection limit of 0.0003 %, measured on the individual raw materials.

oNo skin sensitizing, skin corrosive, skin irritating, severely eye damaging or eye irritating substances according to Annex VI Part 3 of the CLP Regulation.

oSubstances listed with relevant conditions in Annex II or IV of Regulation (EC) No 1223/2009 [Cosmetics Regulation] comply with the limits.
